Re: Winding Up and Termination of ZTE (TX) Inc.

To Whom It May Concern:

In accordance with Section 11.052(a)(2) of the Texas Business Organizations Code (the “*Code*”), you are hereby notified that ZTE (TX) Inc. (the “*Company*”), a corporation that is incorporated under the laws of the State of Texas, pursuant to a duly adopted and approved plan of termination, is winding up its business and affairs.


The Company has commenced the winding-up process by, among other things, distributing this written notice to known claimants of the Company as required by Section 11.052(a)(2) of the Code. While the Company has ceased carrying on its regular business operations (except to the extent necessary to such winding up), it expects to continue paying all known and undisputed claims in the ordinary course of business as such claims come due. The Company expects to apply and distribute all its property, to the extent possible, to (a) discharge all its just and equitable liabilities and obligations, or (b) make adequate provision for the application of such property, in compliance with the Company’s plan of dissolution and Section 11.053 of the Code.

Once the Company has concluded the foregoing actions and other actions that are required by the Code for its winding-up, the Company expects to file a certificate of termination of its legal existence with the Secretary of State of the State of Texas and thereby terminate its existence under Texas law.

If you received this notice in your capacity as a representative, agent, nominee, or attorney for a party holding (or believed to hold) claims against the Company, you are hereby requested to provide a copy of this notice to such party immediately.
